President's Corner

1975... That's the year North Pinellas County Retired Educators Association was formed. Area retired educators needed a unified, non-partisan voice to speak to the legislature on issues

related to state pensions, Social Security, Medicare, and other benefits. The North Pinellas chapter would serve as a **local advocate** for these issues.

What were you doing in 1975? I was living in Broward County, entering the 8th grade, and thinking about becoming a history teacher when I grew up. I would have never guessed that 50 years later I would be living in Pinellas County.

1985... The North Pinellas County Retired Educators Association was 10 years old. They were helping to maintain social connections for retirees. For many, retirement can mean losing daily interaction with colleagues. NPCREA provided a way for former coworkers to stay in touch through regular meetings and social activities.

What were you doing in 1985? I had graduated from college and was starting my second year of teaching middle school 8th grade history in Pasco County. I would have never guessed at that time, that 40 years later I would be retired and living in Pinellas County.

1995.... The North Pinellas County Retired Educators Association was 20 years old and was helping members continue community service. Many retired educators still feel a strong connection to their profession and community. NPCREA organized opportunities for members to continue contributing, such as volunteering or providing scholarships to aspiring teachers.

What were you doing in 1995? I was married, living in Hernando County, and giving birth to my

daughter, Jordan. I was entering my 12th year of teaching 8th grade American history at Bayonet Point Middle School in Pasco County. I still had no idea, that 30 years later I would be retired and living in Pinellas County.

2005: The North Pinellas County Retired Educators Association was 30 years old. They were actively involved in disseminating information. As an affiliate of the state-level Florida Retired Educators Association (FREA), NPCREA served to inform its members about relevant policy changes, programs, and opportunities.

What were you doing in 2005? I was teaching Geography and American History on a mega team of 220 kids at River Ridge Middle/High school and entering my 22nd year of teaching.

2015: The North Pinellas County Retired Educators Association was 40 years old. The monthly luncheons with excellent speakers helped **broaden the knowledge base** of our members as well as allowed them an opportunity to contribute to community programs.

What were you doing in 2015? I was now a widow whose kids had gone off to college and into the workforce. I was teaching civics at River Ridge Middle School and had entered the DROP program as I began my 32nd year of teaching.

2025: The North Pinellas CREA is 50 years old. We are still doing all the great things we have been doing since 1975 and coming up with even more ways to engage with one another. We have had amazing people who have stepped up to keep this organization moving forward and doing their best to encourage others as well.

What are you doing in 2025? I'm in Pinellas County in my fifth year of retirement, happily remarried, and involved in an amazing group that celebrates retired educators. My point is, we never know where life will take us, but we should embrace the adventure and look at what we're doing now and where we will be in the future.

Marie Grein Mama NPCREA

Marie Grein has been "Mama NPCREA" for 33



years since her retirement in 1992. After teaching in Middletown, Connecticut, for three years, she moved on to Dept. of Defense schools in Labrador, England, and Germany, then four more years in Connecticut. Finally realizing where the best lifestyle was to be had, she moved to Clearwater and taught math, science,

and social studies to fifth graders for 26 years at Belleair Elementary School.

After retiring in summer 1992, she joined North Pinellas CREA for their first meeting in September. In those days they met at a large motel on US 19 but soon moved to Stacey's Buffet in Clearwater. She was immediately enlisted to be Vice President in 1993, planning programs for the group of retirees. No sooner did she plan her first year of programs than the president of NPCREA abruptly resigned, leaving Marie to be president.

As president in 1992-94, she was soon enlisted to accompany the District 6 Director as she traveled her route among the surrounding retired teacher groups in South Pinellas, Tarpon Springs, Oldsmar, Palm Harbor, West Pasco, and Hernando counties. When Marie completed two years as president of NPCREA, she became District 6 Director in 1995. She promoted District 6 yearly meetings beginning in 1996, first held at Faith United Church of Christ on Drew Street. She typed and then colored with crayons the programs for these yearly meetings!

From District Director, she was promoted to Vice President of Florida Retired Educators Association (FREA) in 2006 and became President of FREA from 2008-2010. She is proudest of the Mission Statement that she and past presidents Esther Twitchell and Cathy McCartney created:

The mission of FREA is to:

- Safeguard the strength of the Florida Retirement System
- 2. Support public education in Florida
- 3. Provide fellowship opportunities
- 4. Encourage community involvement in education
- 5. Be a source of information and materials.

Her most vivid memories from 33 years of membership in NPCREA and FREA are meeting old friends at State Conventions, playing Bridge-O-Rama with Phyllis Walls, and winning first place in the FREA costume contest in a bikini coverup at State Convention. Best of all, she helped establish the Practicing Educator Grants of \$1000 given each year to educators with an innovative educational plan but no school funding. She donated the first \$1000, and continues to do so, while the FREF Foundation funds a second grant each year.

She served as NPCREA treasurer for over 20 years and FREA Treasurer for 15 years. Along the way, she was a member and president of the Clearwater Community Woman's Club, a member of the Eleanor Roosevelt Chapter of Kappa Delta Pi, international honor society, and an officer of Alpha Delta Kappa, sorority of women educators. She's especially proud of being a member of "The 99s," international order of female pilots, serving as Governor in the Southeast region for two years.

She's very special and truly the best "mama" that our North Pinellas retirees could wish for!
